RULES GOVERNING THE AWARD OF ICAR NATIONAL PROFESSOR INCLUDING B.P. PAL CHAIR

1. Objectives:

The overall objective of the scheme is to recognize outstanding/ eminent scientists who create through their project work a culture of basic research in the National Agricultural Research System. To this end, the ICAR National Professor should interact with other scientists in the System, participate in seminars and conferences to present papers, organize training programmes for younger scientists, be an active member of the teaching faculty, and deliver special lectures at other institutions in the country.

2. Eligibility:

The main criteria for the award shall be the excellence of an individual contribution and achievement and his/ her potential to take up mission oriented research and education in the field of his/ her specialization. The position shall be open to Indian Scientists working in the well recognized Institutions of research and education in the country or abroad. The individual selected for the position should not be below the rank of Professor of 8 years standing and in the age group of mid fifties. The upper age limit for applying for the position should not be more than 55 years in any case.

3. Nature and Duration of Award:

The ICAR National Professorship shall be given a tenure for a period of five years. Based on high quality output, and subject to the evaluation by the Peer Review Committee, the tenure of the ICAR National Professor could be extended for a period up to five years maximum. No extension beyond the age of 65 years should be granted to any ICAR National Professor.

4. Number of Positions:

The total number of positions of ICAR National Professor (including one B.P. Pal Chair in Genetics and Plant Breeding at Indian Agricultural Research Institute, New Delhi) shall not exceed 10 at any given time.

5. Salary:

The position of ICAR National Professorship shall carry a pay of Rs. 25,000/- per month plus other allowances as per rules of Government of India/ University.

6. Location of Award:

The ICAR National Professor may work at any of the SAU, CAU, ICAR Institutes or any other University with relevant agricultural research. The Institution concerned shall provide the working facilities e.g. laboratory facilities, secretarial assistance, residential facilities etc.

7. Operational Autonomy:

The ICAR National Professor would be an honoured member of the faculty and the Institution shall feel proud of sharing the University/ Institutes Departmental facilities required for his/ her work. He/ she should have freedom in planning and execution of the programme of

the special research unit headed by him/ her. A memorandum of Understanding would be signed between the ICAR, the awardee and the University/ Institution where the ICAR National Professor and his staff would be located to pursue his/ her research and teaching in order to ensure that the host institution provide the infrastructural facilities and other ancillary support required for the effective functioning of the project. The ICAR National Professor shall enjoy full freedom to operate the budget of the research project up to the financial sanction and within the scope of the Memorandum of Understanding agreed between the ICAR, the awardee, and Host Institution.

8. Accepting other assignments including foreign assignments:

A National professor will be permitted to accept foreign assignment befitting his/ her status in an international organization for a total period of not exceeding six months during the entire tenure provided he/ she has been invited for international assignment on the basis of scientific standing and reputation. Such assignment will not include participation in Conference, Seminars and Symposium etc. for calculating the time.

9. Financing:

The budget for the Scheme of ICAR National Professor would be Rs. 25.00 lakh for each ICAR National Professor per year for first two years and subsequently, budget allocation should be determined by research project needs subject to a ceiling of Rs. 100.00 lakhs including expenses on salaries and other incidental expenses of ICAR National Professor and the staff. The entire budget shall be provided by the ICAR. The budget will be provided under the “Non-Plan”.

10. Supporting Staff and facilities:

The ICAR National Professor shall have the following staff: (i) Senior Scientist/ Associate Professor – one, (ii) Research Associates (RA) – two, (iii) Laboratory Technician/ Laboratory Assistant – two, (iv) Research Fellows – two, (v) P.A. – one, (vi) Vehicle Driver (if car is provided) – one. Staff at S. No. (i), (iii) and (v) would be deployed from the existing strength of the University/ Institute. Other staff will be taken on contractual basis. Pay/ remuneration and allowances of all the above as applicable in the University/ Institute will be met by the ICAR. The assets created will lapse to the host institution on the conclusion of the project.

11. Procedure for selection:

The selection would be done by a Search-cum-Selection Committee comprising of the following:

The above Search-cum-Selection Committee would be constituted with the approval of the President, ICAR Society and its recommendations will also be approved by the President, ICAR Society. The Search-cum-Selection Committee would formulate criteria, other modalities

for inviting nominations and selection. The proposals would be invited in the prescribed proforma. The appointment would be made after selection is approved by the President, ICAR.

12. Monitoring Mechanism:

ICAR would put in place a system of monitoring the progress through annual progress reports submitted by the ICAR National Professor. The Director General may appoint a high level Committee of three experts for review of the progress after every two years and at the end of the term. His/ her findings would be trendsetters and would be put up for information and use by the other scientists in the research system. The report will include papers published in journals of high impact value.

SERVICE CONDITIONS

- (i) For all practical purposes scientist appointed as ICAR National Professor will be an employee of the host Institution.
- (ii) He/ she will enjoy the benefits of leave, medical facilities/ accommodation etc. as any other employee of the host institution.
- (iii) He/ she will be eligible for pension/ CPF facilities as per the rules of the parent institution. The ICAR National Professors who serve under the Scheme upto 65 years of age will stand retired at the age as applicable for other scientists of the parent Institution but will continue as ICAR National Professor till the end of the tenure or 65 years of age whichever is earlier. He/ she will be eligible for pension etc. benefits fixed on the salary at the time of attaining the age of retirement in normal course. These will be received by him/ her after he/ she ceases to be ICAR National Professor. The responsibility of providing pension and other retirement benefits will rest on the parent institution.
- (iv) In case the ICAR National Professor opts to work in an institution other than his/ her parent institution, the parent institution will be responsible for pension and other retirement benefits as mutually agreed at the time of option. However, the host institution will facilitate fixation and payment of pension and other benefits.
- (v) A National Professor will be permitted to accept foreign assignment befitting his/ her status in an international organization for a total period of not exceeding six months during the entire tenure provided he or she has been invited for international assignment on the basis of scientific standing and reputation. Such assignment(s) will not include participation in conference, seminars and symposium etc. while calculating the time.
- (vi) The ICAR National Professor is expected to devote full time for his/ her approved project. Hence, he/ she would not accept any other position in the University/ Institute except Chairmanship/ Membership of important scientific committees.
- (viii) The offer of ICAR National Professor will remain valid only for a period of 6 months from the date of issue of the order.
