If required, a certificate from the parent organization to that effect may be obtained along with the application.

In view of above, all concerned are hereby requested to give a wider publicity to the Vacancy Announcement amongst all the Organizations/ Institutes /CAUs/ SAUs/ Officials concerned and forward the applications so received from the candidates to this Department. The deadline for receiving the applications for the above professional posts is 18.11.2021.
