



**Sub: Application of Model Code of Conduct -General Election from 96 - Patkura Assembly Constituency of the State Legislative Assembly of Odisha and 8-Vellore Parliamentary Constituency of Tamil Nadu - reg.**

Sir,

I am directed to refer to the Press Note No. ECI/PN/23/2019, dated 10<sup>th</sup> March, 2019 whereby the Commission had announced the schedule for holding General Elections to the Lok Sabha and to State Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim and certain bye-elections.

2. The Returning Officer for 96-Patkura Assembly Constituency of Odisha had, under the provisions of sub-section(1)(c) of section 52 of the Representation of the People Act, 1951, adjourned the poll due to death of one contesting candidate, Shri Bed Prakash Agarwalla.

3. The notification calling General Election to 8-Vellore Parliamentary Constituency of Tamil Nadu vide Notification No. 464/EPS/2019(2) dated 19.03.2019 was rescinded by the President in pursuance of the Commission's proceeding no. 464/ECI/LET/TERR/TN/SS-I/2019 dated 14.04.2019. The Commission issued Press Note No. ECI/PN/49/2019 dated 16<sup>th</sup> April, 2019 in this regard.

4. Now, the Commission has announced the schedule for holding General Election from 96 - Patkura Assembly Constituency of the State Legislative Assembly of Odisha and 8-Vellore Parliamentary Constituency of Tamil Nadu vide its Press Notes No. ECI/PN/69/2019 and No. ECI/PN/70/2019 both dated 4<sup>th</sup> July, 2019.
