



**Subject:- General Election to the State Legislative Assembly of Bihar, 2020 and by-election to one Parliamentary constituency in Bihar and several Assembly constituencies in various States - Lifting of Model Code of Conduct reg.**

Sir,

I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of election schedule by the Election Commission and it remains in operation till completion of election process.

2. Now, that the results in respect of General Election to the State Legislative Assembly of Bihar, 2020 and the by elections for one parliamentary constituency in Bihar and several assembly constituencies in various States have been declared by the respective Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect except in the five counting locations being used for MLC elections in Bihar on 12<sup>th</sup> November, 2020.

3. This may be brought to notice of all concerned.
