You are aware that the Council is running the Scheme for **Emeritus Professor** in the field of **Agriculture and Allied Sciences**, to be located at State Agricultural Universities/ICAR-DUs/CAUs/ CUs with agriculture faculty under National Agricultural Research System (NARS) as per Guidelines of the Scheme (**Please visit [www.icar.org.in](http://www.icar.org.in) for details and revised Guidelines of Emeritus Professor Scheme**). Applications are hereby invited from eligible superannuated/superannuating professionals of NARS in the field of agriculture and allied sciences for filling up of Emeritus Professor positions.

The ICAR-Emeritus Professor programme aims to utilize the talent and services of outstanding superannuated scientists/teachers from NARS in teaching UG/PG courses, other related activities such as student research guidance and developing instructional material/text books including e-learning resources for use in national agricultural education programme and distance education.

The benefit of the Scheme shall be open to all the scientists/teachers at the level of Principal Scientist/ Professor and above from NARS that includes State Agriculture Universities, Deemed Universities, Central Agriculture Universities, Central Universities having agriculture faculty, Centre and State funded Institutions/ Organizations engaged in Agriculture Research, Education, Human Resource Development and Extension. The proposal shall be for teaching of specialized courses and developing instructional material for use in national agricultural education programme including distance education in the field of Agriculture, Veterinary Sciences & Animal Husbandry, Home Science, Dairy Technology and Allied Sciences. The applicants having one year of service left or superannuated before one year as of **15<sup>th</sup> January, 2018** will only be eligible for consideration under this scheme and should send 5 copies of the application prescribed format (Proforma A, B and C).
