Sub: Failure of aadhaar based payment due to "Inactive aadhaar".

I am directed to refer to the subject cited above and state that one of the major reasons for returns/failure in aadhaar based payments has been found to be "Inactive Aadhaar" i.e. aadhaar number getting de-seeded from NPCI mapper by bank due to closure of account or account becomes ineligible to receive any credit. In such cases, the beneficiary has to approach his/her bank to get their aadhaar number re-seeded in NPCI Mapper.

In order to ensure that the failure on account of aadhaar based payments are reduced to the bare minimum, it is requested to advice the scheme implementing agencies which are making aadhaar based DBT payment to sensitize user/beneficiary about re-seeding of aadhaar. It is also advised to conduct re-validation of aadhaar number on NPCI mapper before initiating aadhaar based payments.
