Sir/Madam,

The issue to fix the validity period of reserve panel for the future examinations for the posts of Senior Technical Officers (STOs) and Subject Matter Specialists (SMSs) to be conducted by ASRB has been considered and the Competent Authority in the Council has approved the following:-

- 1. The validity period of the reserve panel is fixed as 18 (eighteen) months for the future examinations to be conducted by ASRB for the posts of Senior Technical Officers (STOs) and Subject Matter Specialists (SMSs). This period of 18 (eighteen) months is to be considered from the date of issue of the final result by the Technical Services Division (TSD) of the Council to the respective Institute. In case of ICAR headquarters, this period of 18 (eighteen) months is to be counted from the date the result is received by the Technical Services Division (TSD) of the Council from ASRB.
- 2. This reserve panel is to be used only after the final selection list is exhausted by the respective institute/ICAR headquarters after giving full opportunity to each candidate, as per the terms and conditions of the offer memorandum.
- 3. Reserve panel is to be used in conditions when the candidate does not join or joins but resigns or dies after joining/accepting the offer.
- 4. However, under all circumstances, the reserve panel is to be used upto a period of 18 (eighteen) months only, from the date the final result is sent to the respective institute by the Technical Services Division (TSD) of the Council.
- 5. This reserve panel is to be used for the advertised vacancies only.
