Sub: Conducting of Nation-wide Pension Adalat on <u>23<sup>rd</sup> August</u>, <u>2019</u> as part of 100-days strategic and impactful initiative with regard to minimize the Pensioners grievances: regarding.

Reference: F. No.: 1/12/2019-P&PW (E) Pt., dated: July, 19th, 2019 from DoPT.

This is in continuation to previous directives issued vide F. No.: FIN/10/09/2018-Pension, dated: 4<sup>th</sup> September 2018 in pursuance to the D.O. no.: 42/11/2018-P&PW (G) dated: 10 July 2018, with regard to the holding of the "Monthly Meeting with Pensioners," as part of good governance to minimize the grievances related to pensioners.

As decided by the Government, Secretary, DoP&PW has conveyed that as part of its 100 days impactful initiatives, Nation-Wide Pension Adalat be conducted by each Ministry/Department/Organizations/Field formation on Friday, 23<sup>rd</sup> August, 2019.

The main objective of the 'Monthly Meeting with Pensioner" would be prompt and quick redress of pensioners grievances, within the framework of extant policy guidelines. While holding these meetings each Pension Authorization Unit should ensure the presence of all concerned stakeholders across the table, viz. officials in charge of Pay fixation, & Pension processing, PPO issuing branch, Finance & Accounts Officer, Heads of Offices sanction Pension, as well as senior officials of the concerned Banks. A notice in advance, intimating the time and venue of the Monthly Meeting for the month of August to be organized on 23<sup>rd</sup> August 2019, should also be sent to the pensioners/family pensioners so that he/she or his/her representative can be present to plead his case. For effective redress across the table, it is imperative that the Pension Authorization Unit should, in advance examine the cases and make preparations for the Monthly Meeting.

A nodal officer may be nominated from each Pension Authorization Unit who will coordinate both within PAU and all constituent units of ICAR attached to it and will also intimate the Council the status and number of cases being taken up in the 'Monthly Meeting with Pensioner' of the Pension Authorization Unit and the outcome of the Meeting organized by your PAUs in the prescribed proforma as mentioned below.
