Poonam Singh and above Shri Riyaz Ahmad by issuing an addendum vide Council's letter No.F.3-2/2012-Estt.I dated 05.08.2016 (copy enclosed).

- 2. Consequently, Shri Jaspal Singh was promoted in the grade of Administrative Officer notionally w.e.f.16.08.2013 through a DPC meeting held on 24.07.2017 to review of proceedings of DPC meeting held on 11.07.2013 vide Council's O.O. No.F.3-3/2017-Estt.I dated 22.12.2017.
- 3. In the meanwhile, the seniority list of the post of Administrative Officers was finalised and circulated vide Council's letter No.F.5-2/2017-Estt.I dated 10.11.2017. The name of Shri Jaspal Singh could not be included in the said seniority list as he was promoted later on the basis of a review DPC. Now, as per the relevant instructions on the subject, the seniority of Shri Jaspal Singh, AO has been determined and interpolated at Sl.No.53(a) below Smt. Poonam Singh, AO in the inter-se-Seniority of Administrative Officers modifying the seniority list issued vide Council's letter No.F.5-2/2017-Estt.I dated 10.11.2017 as under:-

### ADDENDUM

The Seniority of AAOs appointed upto 31.12.2008 was finalized earlier vide Council's letter dated 04.03.2011.

While preparing the new Seniority list of AAOs (appointed during 01.01.2009 to 31.12.2013), it has been noticed that the name of Shri Jaspal Singh, AAO was not mentioned in the said Seniority list. On examining of the issue, it has been informed by the Institute viz. DWR, Karnal vide their letter No.F. 19(3)Estt.II/2014/3407 dated 29.06.2016 that at the time of finalizing the old Seniority list circulated on 04.03.2011, Shri Jaspal Singh was undergoing a major penality of dismissal from the ICAR Service w.e.f. 29.02.2008 which was reduced to compulsory retirement and then further reduced into minor penality of withholding of next increment for a period of five years with cumulative effect w.e.f. 18.07.2011 vide Order no.69-5/2006-Vig. dated 18.07.2011. Shri Jaspal Singh rejoined the post of AAO on 25.07.2011 at DWR, Regional Station, Shimla. The intervening period i.e. 29.02.2008 to 24.07.2011 was decided to be treated as Dies-non for pay only but counted for the purpose of Pension etc.

Now, the competent authority has decided that seniority of Shri Jaspal Singh may be restored and his name may appear at Sl.No. 43(a) below Smt. Poonam Singh and above Shri B. Riyaz Ahmad in the Seniority list circulated vide letter dated 04.03.2011 as per his date of appointment in the grade of AAO i.e. 29.04.2000.
