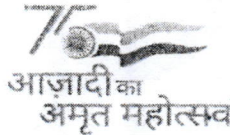

Dear Secretary,

As you are aware, the 2nd National Conference of Chief Secretaries was organized in New Delhi from January 5 – 7, 2023, in which the Ministry of Women and Child Development along with Lead States Maharashtra and Uttar Pradesh made presentation before the Hon'ble Prime Minister on the two sub-themes namely "Creating Enabling Ecosystem for Safety and Empowerment of Women" and "Economic Empowerment" under broad pillar "Empowering Women".

2. After the detailed presentation, open house discussion and guidance given by the Hon'ble Prime Minister, certain action points emerged that are crucial for ensuring safety, security and economic empowerment of women and girls in the country and in realizing the vision of the Hon'ble Prime Minister of turning around the country as a developed nation during 'Amrit kaal'. The detailed action points along with timelines and the responsible Authorities to ensure implementation of the directions are attached at Annexure. Though the implementation of the action points mainly lies with the States/ UTs, the Central Ministries/ Departments who are concerned with the subject matters have a critical role in co-ordination with the relevant line Departments of States/ UTs at regular intervals through issue of advisories/ guidelines and talking follow-up actions so that implementation is completed within the prescribed timelines.

3. While Chief Secretaries of all States/ UTs have been requested to take appropriate action at State/ UT Level on the respective Action Points and share the progress made to this Ministry on monthly basis, I shall be grateful if appropriate action is taken by your Ministry on the respective points and Action Taken Report is shared with this Ministry at the earliest latest by 20th March, 2023. Since, the timelines are spread across the year, I further request you to update the Ministry on progress made on action points during the intervening period on a Monthly basis by 5th of every month from April, 2023 onwards.
