## Office Order

In terms of Jt. Director (Admn.), IARI office order No.JD(A)/Misc./2020 dated 19.04.2020 conveying that:-

# Office Order

In view of the Notification of Delhi Govt. to include Buddh Nagar (JJ Colony), Inderpuri area as Hot Spot Zone, and decision of the Chief Minister, Delhi dated 19-4-2020 for no relaxation in lock down, the Director, IARI reviewed the Office Order dated 18-4-2020 and in supersession, it has been decided that, as IARI falls under the Containment Zone, all officers/officials residing outside the campus will work from their home including those who are residing in the Campus, they will not come to the office till 3-5-2020 and until further orders, except for the essential services as notified by the Ministry of Home Affairs, and Ministry of Health and Family Welfare, Govt. of India.
