It is also informed that the name of Shri Ratnesh Kumar was not included/reflected in the previously finalised seniority list dated 23.12.2014, as till that time recommendation of DPC proceedings were kept in sealed cover and his case for promotion was not decided. However, later on, he has been granted promotion notionally w.e.f. 17.09.2010 i.e. joining of his immediate junior, by opening sealed cover recommendations of DPC meeting held on 02.08.2010 vide Council's office order No 2-4/1992-Estt.I (Pt.) dated 09.01.2017. Therefore, his name has now been included in the provisional seniority list and earlier finalised seniority list dated 23.12.2014 is modified to this extent. Representation, if any, indicating discrepancy/omission etc. will be entertained to this extent only from the concerned officer.
