### OFFICE ORDER

The Division-wise/ Section-wise staff strength of Assistants/ UDCs/ LDCs at ICAR Headquarters was fixed and communicated vide Council's Office Order No.2(3)/2005-W.S.(Vo.-II) dated the 04<sup>th</sup> December, 2012. Over the years some new Divisions/ Sections have been created and some Divisions/ Sections have become outdated. With the approval of Competent Authority in the ICAR, a Committee under the Chairmanship of Secretary, ICAR has considered Re-structuring and Re-staffing or Staffing-a fresh in the Divisions/ Sections of ICAR Hqrs. The following recommendations of the said committee with regard to Restructuring and Re-staffing or Staffing-a fresh in the Divisions/ Sections have been approved by Competent Authority in the ICAR:-

### Following Sections shall be created :-

- (a) A new Section viz. Agricultural Extension-III Section in Agril. Extn. Division shall be created in addition to the existing two Sections viz. Agril. Extn-I and Agril. Extn-II Sections.
- (b) A new Section viz. Recruitment-III Section in ASRB shall be crated in addition to the existing two Recruitment Sections viz. Recruitment-I and Recruitment-II Sections.

#### Following Divisions/ Sections shall be merged :-

- (a) HRM Division shall be merged with Work Study Section. The PA and Deputy Secretary posted in HRM Division shall be placed at the disposal of Administration Division. The strength of Work Study Section shall remain the same i.e. three Assistants, one Section Officer, one Under Secretary and one Deputy Secretary.
- (b) Receipt and Despatch Sections located at Krishi Bhavan and Krishi Anusandhan Bhavan shall be merged.
- (c) Estate & Maintenance Section and Service Section shall be merged as these sections are doing almost similar functions.

#### Abolition of Section:-

Grants-in-Aid Section shall be abolished as the AP Cess fund schemes have become non-functional and ad-hoc schemes have almost ceased to exist. Sanctioned strength of 04 Assistants in Grants-in-Aid section shall be placed at the disposal of Administration Division.

### 6. Reduction in staff strength:-

- (a) One post of Assistant shall be withdrawn from Engg. Cell under 'Works' Division.

- (c) Two posts of Assistant, one each in Receipt and Despatch Sections located at Krishi Bhavan and Krishi Anusandhan Bhavan-I, shall be withdrawn.

- 7 The following decisions have also been taken:-
  - (a) All the Sections under IC Division shall work under the supervision of OSD (International Relations).
  - (b) One Director from Agril. Extn. Division shall be withdrawn and a Junior Officer shall be provided in his place in Agril. Extn. Division.
  - (c) One Under Secretary each shall be posted in Agril. Engg. and Fisheries Divisions and one common Deputy Secretary shall be posted to look after both 'these Divisions.
  - (d) Two Assistants (one each from Per-II Sec and CR Cell) shall be provided to the newly created PIMS Cell under Personnel Division.
  - (e) Posting of one additional Assistant in excess of para-4(c) above from erstwhile Vigilance-II Section (presently DA&A Section) to Vigilance Section (erstwhile Vigilance-I Section)
  - (f) In future all the complaints received shall entered in CPGRAM and then distributed either to Subject Matter Divisions or Vigilance Division.

The Council's Office Order No.2(3)/2005-W.S.(Vol-II) dated 4<sup>th</sup> December, 2012 shall stands revised to this extent.
