Sub- Revision of flat rates of license fee for residential accommodation under ICAR headquarters pool accommodation at Krishi Vihar, Asiad Games Village complex and NASC Complex w.e.f 01.07.2020.

The revised rates of license fee are effective from 01.07.2020. Recovery of water charges and street/staircase lights will be continue to be made at the existing rates as detailed above. Dues towards arrears w.e.f. 01.07.2020 may also be deducted from respective employees.

All DDOs of ICAR Headquarters should ensure the deductions of license fee at above rates w.e.f 01.07.2020. Arrears, if any may also be deducted from respective allottees.

The above license fee is applicable in respect of ICAR headquarters pool accommodation at Krishi Vihar Colony, Asiad Games Village and NASC Complex, New Delhi.
