After detailed deliberations, the Committee recommended the following:

2. Para 5:

a. All Ministries/Departments may take action expeditiously to implement the PPP MII Order 2017 in letter and spirit to encourage domestic industry particularly in view of recent developments. All Ministries/Departments may

- i. Issue notification for the items where there is sufficient local capacity and competition and where public procurement shall be done only from local suppliers under clause 3(a) of PPP-MII, Order 2017.
- ii. Issue notification for the items, being manufactured in India under license from a foreign manufacturer holding intellectual property rights and where there is transfer of technology agreement, in compliance with clause 13 of the PPP-MII Order 2017.
- iii. Notify Government procurement projections of commonly procured items for the next 3-5 years, including the requirements of PSUs and other bodies under their administrative control, to enable domestic industry to suitably increase manufacturing capacity.

Subject: Public Procurement (Preference to Make in India) Order – 2017.

A meeting of Committee of Secretaries (CoS) was held under the chairmanship of Cabinet Secretary on 21.05.2018 at 03.15 PM in the Committee Room, Cabinet Secretariat, Rashtrapati Bhawan to consider Note No P-45021/2/2017-PP(BE-II) dated 16.05.2018 of D/o Industrial Policy and Promotion (DIPP), on the subject mentioned above.

2. Secretary, DIPP informed that Public Procurement (Preference to Make in India) [PPP-MII] Order, 2017 was issued on 15.06.2017, and thereafter, three meetings of Standing Committee on Public Procurement have already been held. The Order provides preference to domestic suppliers in public procurement of goods, services or works by all Central Ministries/Departments and their subordinate offices, autonomous bodies, Government companies, JVs and SPVs. Secretary, DIPP apprised that Minimum Local Content requirement should ordinarily be 50%, but can be varied by Nodal Ministry. He further apprised that restrictive and discriminatory clauses against domestic suppliers cannot be included in procurement conditions. Further, CVC has directed all CVOs to exercise oversight on all contracts over Rs.5 crore so as to ensure that restrictive and discriminatory clauses against domestic suppliers are not included in the tender documents which must be in sync with PPP – MII Order, 2017. Further, items which meet the local content requirement may also be marked on GeM portal. Moreover, GeM portal should provide for automated comparison with purchase preference and without purchase preference and for obtaining consent of local supplier in those cases where purchase preference is to be exercised. Secretary, DIPP cited some examples of discriminatory conditions being imposed on domestic suppliers, in tenders by Government organizations, such as Railways.

3. Secretary, DIPP stated that Nodal Ministries/Departments are required to undertake certain actions under PPP-MII Order. Minimum Local Content requirement has to be notified in accordance with PPP-MII Order. Foreign suppliers, from a country where Indian suppliers are not allowed to participate in public procurement, should not be allowed to participate in Indian public procurement. Further, Phased Manufacturing Program (PMP) should be notified and implemented by all Ministries / Departments. Secretary, DIPP stated that Nodal Departments / Ministries should ensure that no discriminatory clauses against a domestic supplier are included in tender conditions. Further, a periodic review may be undertaken to increase the coverage and extent (percentage) of minimum local content requirement, apart from verifying adherence to PMP. Secretary, DIPP stated that Nodal Ministries / Departments / procuring agencies should take steps to resolve grievances in respect of violation of PPP-MII Order, received on Central Public Procurement Portal (CPPP), as forwarded by DIPP/Department of Expenditure (DoE). The Department-wise progress is given at Annexure.

4. Secretary, DIPP informed that in a meeting held in PMO on 16.03.2018, it was decided that while international competitive bidding may be followed for procurements funded by multilateral / bilateral agencies, D/o Economic Affairs (DEA) should work with such agencies to ensure that no restrictive or discriminatory clauses against domestic suppliers are included in bidding documents. Secretary, DEA informed that attempts to convince multilateral agencies about minimum local content requirement and PMP have not borne fruit so far. In respect of bilateral agencies, Secretary, DEA informed that it is possible to insert provisions of minimum local content requirement and PMP for tied procurements while it is very difficult to do so in case of untied procurements, except for Japan International Cooperation Agency (JICA). It was suggested that DEA may continue to engage multilateral / bilateral agencies and convince them about the necessity of minimum local content requirement and PMP in the context

of a developing and industrializing country like India. It may also be examined whether such funding agencies can accept the condition requiring manufacturing in India by an Indian company or foreign company or a joint venture.

5. After detailed deliberations, it was recommended that

- (i) All Procurement Officers may be required to certify compliance of PPP-MII Order before uploading tenders on CPPP. Ministries / Departments concerned may take action against those who insert restrictive tender conditions against domestic suppliers with a malafide intent, or otherwise flout the provisions of PPP-MII Order. PPP-MII Order may be modified to specify that flouting the provisions therein entails disciplinary action.
- (ii) The notification requiring Minimum Local Content and Phased Manufacturing Program for public procurement under PPP-MII Order may be expedited by all Ministries / Departments. DIPP may provide necessary assistance in this regard.
- (iii) DIPP may examine whether the limit of Rs 50 lakhs in procurement value, such that only local suppliers are eligible for public procurement, provided that Nodal Ministry has communicated that there is sufficient local capacity and local competition, is appropriate or requires change.
- (iv) DoE may issue instructions to all IFAs to ensure compliance with PPP-MII Order.
- (v) The decision to relax Local Content requirement due to non-availability of sufficient local capacity may be taken only by Standing Committee on Public Procurement and not by individual agencies / departments. PPP-MII Order may be modified to incorporate this provision.
- (vi) The mechanism of lodging grievances on Central Public Procurement Portal, in cases of violation of PPP-MII Order, may be widely publicized by DIPP.
- (vii) DIPP and administrative Ministries concerned may obtain data about countries which discriminate against Indian suppliers in their public procurement and put in place retaliatory measures against them.
- (viii) DEA may continue to engage multilateral / bilateral agencies for inclusion of the Minimum Local Content requirement and PMP in the projects sanctioned with their funding. It may also be examined whether such funding agencies can accept the condition requiring manufacturing in India by an Indian company or foreign company or a joint venture.
- (ix) DIPP may thoroughly review the implementation of PPP-MII Order by M/o Railways particularly minimum local content limits, timelines for RDSO approvals to the local suppliers, etc. and ensure their compliance with the order.

- (x) Central Ministries / Departments may specify in all CS/CSS that the procurement made by States and Local Bodies would come within the purview of PPP-Model Order, if that project / scheme is fully / partly funded by Government of India
- (xi) All Central Ministries/Departments may ensure that prior experience clause is not too restrictive to exclude all domestic companies.
