OFFICE MEMORANDUM

Subject: Coverage of all funds being received by Autonomous Bodies (ABs)/Sub-ABs under

Office of the Controller General of Accounts vide O.M. No. R-12001/6/2020-GBA-CCA/1004-1040 dated 31.12.2020 has intimated that it is exploring feasibility of coverage of all Central Government Funds received by ABs/Sub-ABs under TSA. To examine the proposal following information is required immediately: -

- a. An ABs/Sub-ABs may receive funds other than Grants in Aid (i.e. GIA General (Head 31), GIA Capital (Head 35) and GIA salary (Head 36)) from the same PAO who is at present releasing assignment for Grants in Aid.
- b. An ABs/Sub-ABs may receive funds from more than one PAOs of the same Ministry/Department, other than mentioned at (a) above.
- c. An ABs/Sub-ABs may also receive Grants in Aid and other funds from PAOs of other Ministry/Department, other than mentioned at (a) and (b) above.

The supporting data in respect of above to explore feasibility of coverage of all Central Government funds received by ABs and Sub-ABs under TSA may be provided as per enclosed annexure

The information is to be shared with the Office of CGA by 6th January, 2021 positively. A copy of O.M. dated 31.12.2020 received from O/o CGA is enclosed for ready reference.
