**OFFICE MEMORANDUM**

**Subject:** Clarification regarding SMH Curie Cancer Centre [Shanti Mukund Hospital], Vikas Marg, Karkardooma, Delhi

The undersigned is directed to invite reference to the Office Memorandum of even number dated 7<sup>th</sup> October 2010 on the above subject, vide empanelled hospitals under different categories the hospitals were notified and to state that as per the para (iii) of the Office Memorandum mentioned above the hospitals that are on the panel of CGHS who have did not apply in response to the fresh empanelment process initiated by the CGHS in second half of 2009 or have not been approved by CGHS under the fresh empanelment procedure can continue to treat CGHS beneficiaries at old( pre-revised ) rates till 25<sup>th</sup> October 2010. On 26<sup>th</sup> October 2010, their names will stand removed from the list of approved hospitals empanelled under CGHS, without any further notice.

However, as there is no hospital, which is exclusively empanelled for Cancer treatment, it has been decided that SMH Curie Cancer Centre a unit of Shanti Mukund Hospitals, Vikas Marg, Karkardooma, Delhi would continue to be on CGHS, Delhi panel at old rates ( rates fixed for Delhi during 2006) till further orders
