He may also be advised to deliver a seminar on the relevant topics at the Institute after his arrival from abroad and also to submit deputation report along with the prescribed Annexure which may be sent by the Institute directly to the ADG (Coord), ICAR, New Delhi within one month of the Scientist's return from abroad, under intimation to this Department.
