Sub: Payment of Honorarium/Sitting Fee to the Non-Official Members on various Committees of the ICAR: Reg.

Sir,

Vide Office Order No.10(3)/97-CDN (A&A) dated 17.09.2009 ICAR, in consultation with Ministry of Finance has enhanced the Honorarium/sitting fee from Rs.500/- to Rs.1000/- per day for the Non-Official members of the Committees viz. IRC (erstwhile SRC), QRT, Scientific Panel, Board Management/ Institute Management Committee (Non-Official Members)/Committees (Experts/Advisers) of ASRB and other Committee (Education Division, NAIP etc.). The Honorarium/ sitting fee in respect of Research Advisory Committee (RAC) as per the earlier Council's letter No.20(7)/98-CDN (A&A) dated the 18th Feb, 2000 is Rs.1500/- per meeting to Chairperson and other Non-Official members in addition to TA/DA as admissible under the ICAR Rules.

It has come to the notice of the Council that several units of ICAR are paying honorarium at higher rates than prescribed vide Council's O.O. No. 20(7)/98-CDN (A&A) dated 18.02.2000 and 17.09.2009 referred to above. DG, ICAR has expressed his displeasure and desired to have the information on rates at which honorarium is actually being paid by various units of ICAR.
