Subsequent to issue of Department of Personnel & Training's OM to 12011/03/2008-first (Allewance) idated 2<sup>nd</sup> September, 2008, and clarifications respect from time to time on the subject cited above, a number of references have been received on certain aspects of Children Education Allowance/Hostel Subject due consideration of the references, in consultation with the Ministry of Finance, Department of Expenditure, the following modifications/alterations are carried out with effect from the date of issue of this O.M. on pro-rata basis.

- E. Development Fec/Parents' Contribution charged by the school/institution in her of tuition fice shall be reimbursed. The Covernment servant will have to certify to the effect that fuition fee has not been charged by the abbod/institution.
- Fee charged directly by the school/institution for catering to the special needs of the child with disabilities, duly certified by the school authorities, shall be reimbursed in addition to items mentioned in para 1(e) of O.M. dated 2.9.2008. The school institution shall be aided or approved by the Central/State Government/UT. Administration or whose tees are approved by any of these authorities.
- in The minimum ago of 5 years, stipulated in O.M. No.12011/03/2008is it (Allowance) dated 11th November, 2008, for disabled children, pursuing non-formal education or vocational training stands removed. Henceforth, there will be no minimum age for any child for claiming reimbursement of Children Foucation Allowance/Hostel Subsidy.
- 2. Cases where reimbursement has been made on the basis of earlier O.M. on the issues reed not be reopened.
