

Also he advised to submit deputation report (7 copies) along with the prescribed Annexure which may be sent by the Institute directly to ADG(TC), ICAR, Krishi Bhawan, New Delhi within one month of his return from abroad, under intimation to this Department. Further, the duration of the visit shall not be extended.


