He may also be advised to submit deputation report (7 Copies) along with prescribed Annexure to ADG(TC), ICAR, Krishi Bhawan, New Delhi direct within one month of his return from abroad, under intimation to this Department. A copy of Duty Bond executed by the applicant along with amount break-up of Duty Bond may also be supplied to this Department for reference and record.
