

A meeting of the following officers of ICAR was held to discuss the issue of hiring of security services for institutes of ICAR on 11.10.2010 at 3.00 p.m. in the chamber of Secretary, ICAR.

1. Sh. Rajiv Mehrishi, AS(DARE)& Secretary ICAR

The Secretary, ICAR expressed concern that for want of budget support the security of ICAR institutes should not be compromised. He maintained that professionally trained security personnel are required to be engaged in the ICAR institutes to avoid/prevent any mishappening, given the present circumstances . All the other members also appreciated that issue regarding providing adequate security by trained and professional ex-servicemen is an urgent requirement .In view of this the following points were agreed upon:-

1. The security personnel to be hired by the institutes should be ex-servicemen alone, and none else, as ex-servicemen are better trained and disciplined than untrained and young civilians. Re-employing the serviceman is also policy of the government.
2. The hiring of ex-servicemen would be preferably by means of direct contract with them i.e. without intervention of any agency; the procedure of this has been indicated in pg. 5 of F.No. 17 (1)/2010-Estt.II dt. 11. June 2010 already circulated to all Directors.
3. The consequential, budgetary requirements of the various units shall be appropriately addressed on finalization of the proposals.
