**OFFICE MEMORANDUM**

**Sub: Revision of rates of damage rent for residential accommodation under ICAR Pool at Krishi Vihar, Asiad Games Village Complex and NASC Complex w.e.f. 01.01.2013.**

This is in partial modification of this offices O.M. of even number dated 31<sup>st</sup> January 2013 on the subject quoted above. In pursuance of the decision taken by the Govt. of India, Ministry of Urban Development, Directorate of Estates vide their O.M. No. 18011/2/2006-Pol.III dated 04.06.2013, it has been decided by the Competent Authority to revise the rates of damage rent for various types of Council's accommodation i.e. Type-I to Type-VII residence allotted to ICAR employees. 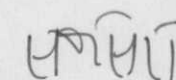
