OFFICE ORDER

Sub: Re-organizing the process of release of funds under AICRP schemes with PC units located in the SAUs-reg.



The UCs/ AUCs for the year 2011-12 may be monitored/ accepted by the respective institutes/ Project Co-ordinators. Accordingly the implementing units may forward the UCs/ AUCs directly to the Project Coordinators/ respective releasing institute from the financial year 2012-13 onwards. The provisions of Rule 212(1) of GFR 2005 in respect of Utilization Certificates are to be strictly complied by all the Grantee institutions before further release of grants are made to them as enunciated in the Council's letter No. 4-1/2000-GA.I dated 20.12.2011.
