#### OFFICE MEMORANDUM

#### <u>Treatment in Institute of Liver & Biliary Sciences, Delhi, by CGHS/</u> <u>beneficiaries under CS (MA) Rules, 1944, without prior permission /</u> approval.

The undersigned is directed to state that the Ministry of Health & Family Welfare has been examining the proposal for permitting beneficiaries under CGHS / Central Services (Medical Attendance) Rules, 1944, to take treatment at Institute of Liver & Biliary Sciences, Delhi, without the need for prior permission from the concerned Department / CGHS Dispensary. It has now been decided that beneficiaries under CGHS possessing a valid CGHS card can avail treatment / investigation facilities at Institute of Liver & Biliary Sciences, Delhi, for which prior referral / permission / approval will not be necessary from the concerned Department / CGHS Dispensary. Similarly, beneficiaries under Central Services (Medical Attendance) Rules, 1944 can also avail treatment / investigation facilities at Institute of Liver & Biliary Sciences, Delhi without prior referral / permission / approval will not be necessary from the concerned Department / CGHS Dispensary. Similarly, beneficiaries under Central Services (Medical Attendance) Rules, 1944 can also avail treatment / investigation facilities at Institute of Liver & Biliary Sciences, Delhi without prior referral / permission / approval. Beneficiaries who are living outside Delhi and wish to undertake treatment at the Institute without being referred by the competent authority will not be entitled to claim TA / DA for the journey to be performed by them for the purpose of treatment.

2. The expenditure incurred on such treatment at the Institute of Liver & Biliary Sciences, Delhi, will be reimbursed as per entitlement of the beneficiary, as per CGHS rates or AIIMS rates or actuals, whichever is less, by the concerned Department / CGHS, as the case may be. Reimbursement, however, in respect of items for which a ceiling has been prescribed, will be limited to the ceiling rate or actual, whichever is less.

3. The entitlement of beneficiaries for indoor treatment, which are not covered by the package rates, etc., will be as under:

S. No.	Basic Pay + Dearness Pay / Basic Pension + Dearness Pension	Entitlement
1.	Upto Rs. 11,250/- per month	General Ward / Triple Shared Ward
2.	Between Rs.11,251/- and Rs. 15,750/- per month	Non-AC sharing room
3.	Between Rs.15,751/- and Rs. 20,250/- per month	AC sharing room / Non-AC single room
4.	Rs. 20,251/- and above per month	AC single room

Room rent for ICCU / Special Intensive Care Unit will be same for all categories.

5. Drugs prescribed by Institute of Liver & Biliary Sciences, Delhi, during OPD treatment will have to be obtained from the concerned CGHS Dispensary on the basis of the prescriptions by specialists.
