**OFFICE MEMORANDUM**

**Sub: Revision of flat rates of licence fee for residential accommodation under ICAR Pool at Krishi Vihar, Asiad Games Village Complex and NASC Complex w.e.f. 01.07.2013.**

In pursuance of the decision taken by the Govt. of India, Ministry of Urban Development, Directorate of Estates vide their O.M. No. 18011/1/2013-Pol.III dated 21.11.2013, it has been decided by the Competent Authority to revise the rates of licence fee for various types of Council's accommodation i.e. Type-I to Type-VIII residence allotted to ICAR employees at Krishi Vihar/Asiad Games Village Complex/NASC Complex as under:-
