<u>CLARIFICATION ABOUT CUT-OFF FOR SHORTLISTING OF CANDIDATE FOR</u> <u>AGRICULTURAL RESEARCH SERVICE (ARS) MAINS EXAMINATION – 2015</u>

- 1. Some candidates have approached the Board seeking clarification that they have not been shown qualified for ARS Mains Examination despite the fact that they have secured more than qualifying marks prescribed in the Notification for the examination i.e. 45% for General category, 40% for OBC and 35% for SC/ST/PwD category.
- 2. In this connection, attention of the candidates is drawn towards clarification given under Annexure VI of the Notification wherein it is mentioned that the candidates for ARS Mains Examination will be shortlisted in the ratio of 1:15 from amongst those who pass the examination as per prescribed standard.
- 3. The marks secured by the last qualified candidate for ARS Prelim under each discipline are given in the attached Annexure I.
- 4. The candidates may please note that if any candidate has not secured the minimum qualifying marks of 45%, 40% or 35% prescribed for the category he/she belongs to or has secured the minimum qualifying marks but the score is less than the last shortlisted candidate under the concerned discipline, Admission Certificates for appearing in the ARS (Mains) Examination shall not be issued and liable to be cancelled / withdrawn if it is noticed at any stage that the candidate has not secured marks as per above mentioned criterion. If the OBC/SC/ST/PwD Category candidates are shortlisted against General Category post then no concession in terms of age, minimum marks etc. shall be admissible to such candidates.
