**Expenditure for Beti Bachao Beti Padhao**

**1 Shri Derek O' Brien:**

Will the Minister of **Women and Child Development** be pleased to state:

- (a) whether it is a fact that 78.1 per cent of the fund for 'Beti Bachao Beti Padhao' have been used only for media advocacy;
- (b) if so, the details thereof; and
- (c) whether the Ministry has taken any measures to improve fund utilization for the implementation of the programme instead of only media advocacy, the details thereof?

**Legislation to provide reservation for local youth in private sector jobs**

**2 Shri Vaiko:**

Will the Minister of **Social Justice and Empowerment** be pleased to state:

- (a) whether Government would bring a model legislation to provide for reservation for local youth in private sector jobs, at the non-executive level;
- (b) if so, by when and the details thereof; and
- (c) if not, how does Government ensure that local residents are given preference in private sector employment, especially when land and other resources are taken away from the local residents?

**Amendment in Panchayati Raj Act**

**3 Dr. C.M. Ramesh:**

Will the Minister of **Panchayati Raj** be pleased to state:

- (a) whether Government, in consultation with State Governments, proposes to suitably amend the existing Act to make Panchayati Raj system more strong, effective and accountable, the details thereof; and
- (b) whether Government proposes to constitute a high powered Committee to study the existing Panchayati Raj system to make it effective and to meet the technology need of rural India, the details thereof and if not, the reasons therefor?

### Recovery of counterfeit notes

### Resolving issues related to Andhra Pradesh Reorganisation Act

- (a) whether the Ministry officials have recently had a meeting with the Chief Secretaries of Andhra Pradesh and Telangana to settle the pending issues of both the States as per Andhra Pradesh Reorganisation Act;
- (b) if so, the details thereof; and
- (c) the outcome thereof?

### Sexual violence within marriages

- (a) whether Government has taken any position regarding inclusion of "marital rape" as an offence under the IPC;
- (b) whether Government acknowledges the prevalence of rape/sexual abuse within marriages or has conducted any study/research on the same, if so, what steps have been taken to address the same;
- (c) the total number of protection orders passed in cases registered under the Protection of Women from Domestic Violence Act, State-wise and category of protection order-wise; and
- (d) the total number of domestic violence crisis centers run by Government or in partnership with civil society organisations?

### PMAY-G in Rajasthan

Will the Minister of **Rural Development** be pleased to state:

- (a) the number of beneficiaries covered under the Pradhan Mantri Awas Yojana-Gramin (PMAY-G) in Rajasthan, district-wise;
- (b) the details of funds allocated for the said purpose during the last three years, year-wise; and
- (c) the percentage of houses completed through funds allocated to beneficiaries, the district-wise details thereof?

### Status of construction of Char Dham Road project

Will the Minister of **Road Transport and Highways** be pleased to state:

- (a) the status of construction of 900 kilometres of Char Dham pilgrimage highway project;

- (b) whether the project has been broken into 53 segments and if so, the reasons therefor;
- (c) whether Government is aware that bypassing of Environmental Impact Assessment (EIA) by segmentation of road projects destroys the ecology of the region; and
- (d) if so, the reaction of Government in this regard?

#### **Skill India initiatives in Uttar Pradesh and Andhra Pradesh**

Will the Minister of **Skill Development and Entrepreneurship** be pleased to state:

- (c) the number of trained persons who have got employment in Uttar Pradesh and Andhra Pradesh, district-wise;
- (d) the role of the private sector and CSR initiatives in skill development initiatives and major initiatives undertaken; and
- (e) the list of skill development institutes established and initiatives taken by Central PSUs?

#### **Tribal people in Namakkal district, Tamil Nadu**
