Air connectivity in West Bengal under UDAN scheme

- *91. SHRI SUKHENDU SEKHAR RAY: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) how many cities/towns in West Bengal have been included in the UDAN scheme to facilitate air connectivity;
- (b) what steps Government have initiated to connect Cooch Behar, Balurghat and Malda by air, where functional airstrips already exist, the details thereof:
- (c) whether Government has any plan to introduce direct round trip Air India flights from International Airport, Kolkata to the capitals of island countries like Singapore, Maldives, Indonesia, Malaysia, Philippines, Sri Lanka etc. for promoting tourism in Eastern India; and
- (d) if so, by when and if not, the reasons therefor?

Underpaid jobs under skill development

- *92. SHRI B.K. HARIPRASAD: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:
- (a) whether it is a fact that not even 50 per cent of the total number of trained persons under skill development in various Ministries got jobs;
- (b) whether it is also a fact that private employees and job seekers are getting underpaid jobs, which is the burning issue in the unemployment sector; and
- (c) the status of promise made by the Prime Minister to give one crore good jobs?

MSME Conclave in Guwahati

- *93. SHRI BHUBANESWAR KALITA: Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:
- (a) whether North East Micro, Small and Medium Enterprises (MSME)

Conclave was held in January, 2018 in Guwahati and if so, the details thereof;

- (b) whether MSME sector is a critical component to India's growth story;
- (c) whether Government would also agree that MSME sector is also making significant contribution to GDP, employment and exports; and
- (d) if so, the details thereof along with the initiatives taken by Government to strengthen the sector in Assam?

Central funding for projects in naxalite affected areas

- *94. SHRIMATI SHANTA CHHETRI: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that the Integrated Action Plan (IAP) for broad co-ordinated operations aimed at dealing with the naxalite problem in all the affected States including West Bengal have borne positive results;
- (b) if so, the details of Central funding for grassroot economic development projects in naxalite affected areas; and
- (c) whether there has been an increased special police funding for better containment and reduction of naxalite influence?

Industrial Park Rating System

Setting up of large scale PNG network

Attacks on RTI workers, whistle blowers and social workers

- (c) in how many cases FIRs have been registered, chargesheets filed, trials and

convictions/acquittals from 2015 onwards, the data thereof?

Cardamom imports from Sri Lanka

- (a) whether the improts of cardamom from Sri Lanka to India is increasing;
- (b) if so, the month-wise details of such cardamom imports from Sri Lanka during the last six months;
- (c) whether Government is in receipt of any complaints about the dubious financial dealings involved in such increased imports of cardamom;
 - (d) if so, the details thereof; and
- (e) whether any inquiry is being done into such complaints?

Increasing the number of seats in Legislative Assembly of Andhra Pradesh

- (a) whether Government is considering to increase the number of seats in the Legislative Assembly of the successor State of Andhra Pradesh:
 - (b) if so, the details thereof; and
 - (c) if not, the reasons therefor?

National Policy on Domestic Workers

- *100. SHRIMATI VANDANA CHAVAN: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:
- (a) when will the National Policy on Domestic Workers be finalised;

- (b) whether in the process of drafting the policy, Government has undertaken a survery to determine the number of people/ children engaged in domestic work;
- (c) if so, the State-wise total number of children and people enaged in domestic work; and
- (d) the plan of Government to ensure safeguards for these people, particularly children, so as to protect them from all forms of abuse and exploitation?

Twelfth Schedule of Andhra Pradesh Reorganisation Act

- *101. SHRI KANAKAMEDALA RAVINDRA KUMAR: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government has settled matters relating to coal, oil and natural gas, power generation, transmission and distribution as mandated in the Twelfth Schedule to the Andhra Pradesh Reorganisation Act, 2014 between the States of Andhra Pradesh and Telangana; and
- (b) if so, the details thereof and if not, the reasons therefor?

Action taken for blocking objectionable content on social media

- *102. SHRI N. GOKULAKRISHNAN: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it has been noticed that action taken by social media platform for removing/blocking of objectionable/ unlawful content has been slow in some cases and compliance for removal of unlawful content has been only about 60 per cent even where orders have been issued by the competent authorities after following due process of law;

- (b) whether it is also a fact that Government has asked them to ensure 24x7 mechanism for disposal of requisition of law enforcement agencies; and
 - (c) if so, the details thereof?

Financial assistance provided as flood relief

- (a) the State-wise details of loss of lives and damage to property and crops due to floods;

- (c) the details of financial assistance provided by Government under SDRF/ NDRF in the wake of floods over the last three years and the current year, year-wise and State-wise; and
- (d) the details of funds released by Government for flood relief and compensation of loss suffered/claimed, year-wise and State-wise, excluding SDRF/NDRF financial assistance during the above period?

Mid-air collision at the border of India and Bangladesh

- *104. SHRI T. RATHINAVEL: Will the Minister of CIVIL AVIATION be pleased to state:
 - (a) whether it is a fact that two private

airlines came too close for comfort before averting a mid-air collision at the border air space of India and Bangladesh recently;

- (b) whether it is also a fact that the collision was averted after the Air Traffic Control in Kolkata instructed one plane to move away from the other aircraft that had come at the same level;
- (c) whether it is also a fact that many such incidents had been reported in the past; and
- (d) if so, the corrective steps taken by Government in this regard?

Foreign national in restricted area in Andaman and Nicobar Islands

- *105. SHRI RAJEEV CHANDRASEKHAR: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that a foreign national had attempted to land in the out of bounds Sentinel Island in the Andamans for the purpose of illegal religious conversion of the native Sentinelese tribe which is an endangered community living in Andaman Island;
- (b) if so, what laws had been violated by the person and those that aided and abetted him and what is the status of prosecution of these people; and
- (c) what steps Government is taking to ensure enforcement of these areas prohibited to foreigners and to ensure strong action against those who violate rules?
