Pollution in rivers due to sewage

- (b) whether orders of National Green Tribunal (NGT) are being complied with for installation of sewage treatment plants for treatment of dirty water of urban drains which is being drained into rivers and water sources of the country; and
- (c) the percentage of water bodies getting polluted due to direct sewage and the details of the steps taken to prevent water sources from getting polluted?
