#### Construction of modern stadiums

- (a) whether Government proposes to construct modern stadiums in the current financial year to encourage the youth from rural areas to participate in sports;
- (b) if so, the State-wise details thereof; and
- (c) the year-wise and State-wise details of the stadiums constructed and the funds allocated during the last three years?

### Amendment to the Antiquity Act

(a) whether it is a fact that any artifact/furniture, etc. which is more than 100 years old falls under the purview of 'Antiquity' and needs to be registered under the Antiquity Act; and

- (b) whether the problem of unemployment is rising but still many industries are facing the problem of shortage of skilled candidates for the companies; and
- (c) whether Government has ascertained the reasons of unemployment in the country and if so, the details thereof along with steps taken to reduce unemployment?

#### Irregularities in Lalit Kala Akademi

- (a) whether Government has been receiving complaints pertaining to the reported administrative and financial irregularities in the Lalit Kala Akademi for past some years;

- (b) the company-wise details of funds spent by Government/oil companies under the said schemes during each of last three years and the current year;
- (c) whether cases of corruption/ irregularities under said schemes have come to the notice of Government during said period, if so, the company-wise details thereof;
- (d) whether Government has conducted any enquiry in this regard; and
- (e) if so, the details thereof along with corrective steps taken by Government?

# Concessions to different sectors of economy

- \*97. SHRI C.P. NARAYANAN: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether any financial concessions have been given to various sectors of industry and commerce in the form of tax, duty reductions, etc. during the last three years, if so, what is the total amount involved:
- (b) what improvement has occurred in production, export, etc., because of this and what has been the growth in the economy; and
- (c) whether there is any recent fall in production in manufacturing and other fields in spite of these promotional measures?

# Implementation of programmes for forest villages

  - (a) the State-wise details of programmes

- (c) if so, the details thereof along with the action taken by Government thereon; and
- (d) the steps taken/being taken by Government to further boost tourism in the country?

## Payment of minimum pension of rupees one thousand

- (c) the corrective steps taken by Government in this regard?

# Influx through international riverine border

### Blending of ethanol with petrol

#### Chinese tourists to India

- (d) whether there is any move to extend Visa on Arrival to China, if not, the reasons therefor?

### Centrally protected monuments

- (d) whether the National Monuments Authority has asked the Archaeological Survey of India (ASI) to re-examine the list of protected monuments, de-notify those missing and add new monuments under Central Government protection; and
  - (e) if so, the details thereof?

#### **Universal Account Number**

- (c) what are the reasons for making the UAN mandatory for the employers?
