- (c) if so, whether the Ministry shall consider amending the POCSO Act to fix this and other flaws?

(c) if so, the details of the steps taken?

- (c) further steps being taken by Government to implement these schemes and to ensure that the same are completed within the fixed time schedule?

#### Grants to foreign universities/ institutions
