**Decrease in the number of branches of Commercial banks in rural areas**

\*166. SHRI K.K. RAGESH: Will the Minister of FINANCE be pleased to state:

- (a) whether there is any decrease in the number of branches of Commercial banks in rural areas in the last three years;
- (b) if so, the details thereof, State-wise;
- (c) whether any specific efforts are being made to help rural consumers in the event of such a decrease in the number of bank branches; and
- (d) if so, the details thereof?

**More excavations by ASI to unearth earlier civilisation**

\*167. SHRI A.K. SELVARAJ: Will the Minister of CULTURE be pleased to state:

- (a) whether it is a fact that the Archaeological Survey of India (ASI) is considering to carry out more excavations in the country to unearth more findings of earlier civilisation;
- (b) if so, the details thereof;

(c) whether it is also a fact that the ASI has come out with a latest report on the findings unearthed from the excavations carried out earlier; and

- (d) if so, the details thereof?

**Utilisation of funds released for Swasthya Mela**

**Efforts to make drug-resistant TB treatment accessible**

(a) whether it is a fact that as of 2019, India has the largest number of individuals suffering from drug-resistant versions of tuberculosis, like multi-drug resistant tuberculosis, extensively-drug resistant tuberculosis and the totally drug-resistant tuberculosis, if so, the details thereof;

(b) whether it is also a fact that delays in treatment are another major factor for deaths due to tuberculosis in India; and

(c) if so, the action planned by Government to overcome this social stigma and lack of access to sound and affordable medical care?

**Professional and training institutions setup under CSR**

\*172. DR. L. HANUMANTHAIH: Will the Minister of CORPORATE AFFAIRS be pleased to state:

(a) whether it is a fact that the current rules of Corporate Social Responsibility (CSR) allow companies to set up professional and training institutions; and

(b) if so, whether it is also a fact that under the instant Rules the industry-specific companies cannot set up their domain-specific technology institutions on a presumption that the passed out students may join the company?

#### **Promotion of herbal medicines**

(a) the details of steps taken by Government to promote herbal medicines in the country;

(c) the details of the States and regions identified by Government to plant herbal medicinal plants and allocation of funds during the last two years for the purpose?

#### **Ayushman Bharat Yojana**

(d) how Government plans to meet the shortfalls?

#### **People qualified to run pathology labs**

(c) the details of the guidelines of the National Accreditation Board for Testing and Calibration Laboratories (NABL) which provide accreditation to the medical laboratories?

#### **Electricity charges in Delhi**
