Prime Minister's package for farmers of Bihar

- *106. PROF. MANOJ KUMAR JHA: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:
- (a) whether it is a fact that the Prime Minister had, on 18 August, 2015 announced a package of ₹ 3094 crore for the welfare of farmers of Bihar; and
- (b) if so, the amount of funds released so far out of the said package?

Data on average monthly/annual income of farmers

- (a) whether there is any National or State level data on the average monthly/ annual income of a farmer in the country, if so, the details thereof;

Installation of CCTV cameras at railway stations and in trains
