Sanctioned projects under Swadesh Darshan Scheme

*196. SHRI A.K. SELVARAJ: Will the Minister of TOURISM be pleased to state:

(a) whether it is a fact that eleven projects have been sanctioned under Swadesh Darshan Scheme in the year 2017-18 alone, taking the total number of projects upto 67;

(b) if so, the details thereof;

(c) whether it is also a fact that Government's plan is for holistic development of pilgrimage destinations across the country, including Buddhist Circuit; and

(d) if so, the details thereof?

Pradesh has made several requests to the Central Government for implementation of several provisions made in A.P. Reorganization Act, 2014 and assurances given during the passing of A.P. Reorganization Bill;

(b) if so, details thereof along with reasons for not implementing provisions of the Act;

(c) if not, what are the provisions fully implemented by Government till now and what are the provisions and assurances still to be implemented; and

(d) by when the provisions/assurances will be fulfilled completely?

Survey on habit of domestic tourists

*198. SHRI A. VIJAYAKUMAR: Will the Minister of TOURISM be pleased to state:

(a) whether Government has conducted any survey on the habit of domestic tourists in the country;

- (b) if so, the details thereof;
- (c) whether many of the domestic tourists undertake visits in an unplanned manner; and
- (d) if so, whether any initiatives have been taken to make Indian citizens undertake tourism in a planned manner?

Crime in Delhi

*199. SHRIMATI KAHKASHAN PERWEEN: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether crimes like vehicle thefts, robbery, chain snatching, eve teasing, rape, etc. in Delhi have increased from January to March, 2018 in comparison to the corresponding period of 2017;
- (b) the number of cases in which criminals could not be identified/arrested during the year 2018;
- (c) the action plan to make Delhi a safe place for living;
- (d) the ranking of Delhi based on crime rate in the country; and
- (e) the names of crime prone police stations in Delhi showing increasing trend and action taken against guilty officers for dereliction of duty?

Steps taken to seal Assam-Bangladesh border

*200. SHRI MAHENDRA SINGH MAHRA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the steps taken by Government to seal and secure the Assam-Bangladesh border;
- (b) how many kilometres of the border have been sealed so far; and

- (c) the measures taken to secure the unfenced portion of the border which includes riverine areas?

Steel plant at Bayyaram

*201. SHRI DHARMAPURI SRINIVAS: Will the Minister of STEEL be pleased to state:

- (a) whether Government's attention has been drawn to the matter of establishment of steel plant at Bayyaram, Khammam district of Telangana which was a promise made in the AP Reorganisation Act, if so, the details thereof;
- (b) whether Government of Telangana has submitted a fresh proposal through its IT Minister requesting the Ministry to expedite the process of establishment of a steel plant at Bayyaram in Telangana, if so, the details thereof;
- (c) whether Government has given any assurance in this regard, if so, the details thereof; and
- (d) the steps being taken by Government to speed up execution work immediately?

Use of Hindi in official work

(c) how much time will the Ministry take to recognize Andhra Natyam as one of the major classical dance forms of India?

Vacant posts in paramilitary forces

(a) whether a large number of posts remain vacant in various paramilitary forces;

(b) if so, the number of such posts which remain vacant in each force; and

(c) the reasons for not conducting recruitment for the vacant posts?

Reduction in share of PDS Kerosene to Tamil Nadu

*205. SHRIMATI KANIMOZHI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether despite demands for increasing allocation, Union Government has reduced the share of Kerosene to Tamil Nadu compared to 2015-16 levels, if so, the reasons therefor; and

(b) whether the Central Government has any plans to enhance the Public Distribution System Kerosene allotment to fulfil the requirement of family cardholders?

Maoist affected districts in Kerala

(a) whether Government of Kerala has recommended extending the list of Maoist affected districts; and

(b) if so, the details thereof?

Non-filing of returns by exempted PF trusts

(a) whether a large number of exempted private Provident Fund (PF) trusts have not filed their return for the last several years;

(b) if so, the details thereof along with the reasons therefor; and

(c) the steps taken by Government to ensure filing of returns by all the exempted PF trusts in order to protect the interest of workers?

National Manufacturing Policy

- (a) whether there is a proposal of Government for framing and implementing a new National Manufacturing Policy (NMP) through which employment can be generated;
- (b) if so, the details of the policy;
- (c) whether the policy has the potential to increase the GDP growth rate at a greater pace as well as remove the unemployment in the country; and
- (d) if so, the action plan prepared in this regard?

Selection of sportspersons under 'Khelo India'

- (a) the procedure for selection of sports events, talent and sportspersons under 'Khelo India' programme being organised this year along with the action plan to train

- (b) the measures taken by the Ministry of Human Resource Development with regard to Part 'a' above at various levels of education for co-ordination of 'Khelo India' programme and selection of talent?

Accidents in PNG sector

- (c) whether any such recommendations have been implemented, if so, the details thereof;
- (d) whether Government proposes to set up Emergency Response Centre for accidents caused due to fire; and
- (e) if so, the details thereof and the timeline for completion of the Centre?
