#### **Suicides by farmers**

†\*226. SHRI SANJAY RAUT: Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether the incidents of farmers' suicides are continuing unabatedly in the country, including Maharashtra;
- (b) if so, the details thereof and the reasons therefor;
- (c) the steps taken by Government to prevent farmers' suicides;
- (d) whether Government has provided financial assistance/funds to the States for the solution of farmers' problems;
- (e) if so, the details thereof, State-wise; and
- (f) if not, the reasons therefor?

#### **Increasing storage capacity of godowns in Maharashtra**

\*227. SHRI RAJKUMAR DHOOT: Will the Minister of CONSUMER

AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether Government proposes to construct new godowns for foodgrains and other agricultural produces at different locations in Maharashtra to help farmers and strengthen Public Distribution System (PDS) in the State;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) whether Government also proposes to increase the storage capacity of the existing godowns in the State; and
- (d) if so, the details thereof?

#### **Reduction in milk procurement prices**

\*229. SHRI JAVED ALI KHAN: Will the Minister of COMMUNICATIONS be pleased to refer to answers to Starred Question 107, Unstarred Question 3424 and Starred Question 138 given in the Rajya Sabha on 25 November, 2016, 16 December, 2016 and 28 July, 2017 respectively and state:

(a) whether advice sought from Central Vigilance Commission (CVC) regarding ₹ 300 crore scam in BSNL in award of contract for expansion of National Internet Backbone and in annual maintenance contract (AMC) along with purchase of new hardware, has been received;

(b) if so, the details thereof along with the date of receipt and legal/penal action taken against the culprits; and

(c) if not, the reasons for delay in taking action against the culprits by Government?

#### **Execution of railway projects in Odisha by RVNL**

(a) whether the Rail Vikas Nigam Limited (RVNL), which has been entrusted with the execution of two railway projects, i.e., Haridaspur-Paradip and Angul-Sukinda in Odisha, is unwilling to take up construction work of these projects due to conflict of interest; and

(b) by when Railways are going to fix up a new agency for early completion of the above projects, which have been targeted for their completion in March, 2018 and June, 2018, respectively ?

(d) whether Government has received any complaints regarding the dissolution or reducing the responsibilities of the FCI; and

(e) if so, the reaction of Government thereto?

- (c) whether Government intends to regularise the jobs of Dak Sevaks as demanded by their union bodies;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

#### **FPIs in Karnataka**

\*234. SHRI D. KUPENDRA REDDY: Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether it is a fact that Karnataka is one of the States which has got the maximum invested capital in the Food Processing Industries (FPIs);

#### **Procurement of farmers' crops**

- (b) whether the Ministry had received any suggestions from public or Members of Parliament pertaining to key reforms during the last three years, if so, the details thereof alongwith the number of such suggestions accepted and implemented ?

#### **Provision of food security allowances**

- (a) the total number of complaints received by Government regarding lack of ration depots within mandated distance, rotten/poor quality foodgrains, insufficient/unavailability of foodgrains, along with the steps taken to address each of these issues during the last five years;
- (b) whether Government has the provision for giving Food Security Allowance in case of non-supply of entitled foodgrains; and
- (c) if so, the details thereof along with the list of beneficiaries?

#### **Infrastructure in Agriculture sector**

(d) if so, the details thereof?

#### **Use of drone cameras**

(a) whether it is a fact that the Ministry has given green signal for the use of 'drone' cameras (UAV/NETRA), if so, the details thereof;

(b) whether any survey has been conducted on the use of drones, if so, the details of the research conducted along with the results thereof; and

(c) the details regarding the additional

financial burden, which the Ministry will have to bear, on the use of this technology on monthly/yearly/Zone/division-wise basis ?

#### **Checking the spread of BG-III cotton cultivation**

(a) whether Government is aware that unauthorised cultivation of herbicide-tolerant cotton seed, popularly known as BG-III cotton, is spreading across the country, which is harmful to the biodiversity;

(c) whether any State Government has complained to the Central Government to check the spread of BG-III cotton, if so, the details thereof;

(d) whether any action has been taken by Government in this regard, the details thereof; and

(e) the steps being taken by Government to check the spread of BG-III cotton cultivation ?
