Diseases due to air pollution in Delhi-NCR

†*241. SHRI VISHAMBHAR PRASAD NISHAD: Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

(a) whether it is a fact that despite taking various proactive measures to check air pollution in Delhi and adjoining areas, the desired result is not being achieved and this has led to various health problems of public at large;

(b) season-wise details of the increasing pollution in Delhi during the last three years and the steps being taken to improve the air quality at present, and the outcome thereof; and

(c) whether it is a fact that due to excessive pollution, pollution borne diseases are on the rise?

Rafale aircraft deal

*242. SHRI SANJAY SINGH: Will the Minister of DEFENCE be pleased to state:

(a) whether Government has entered into an Inter-Governmental Agreement with France for the purchase of 36 Rafale jets in fly-away condition to be manufactured by Dassault Aviation with an offset requirement of manufacturing 50 per cent of equipment in partnership with an Indian company;

(b) whether Dassault Aviation incorporated a Joint Venture to fulfil its offset requirement with Reliance Defence, a company having no prior experience in manufacturing equipments for jets; and

(c) if so, what are Government's comments on the involvement of an inexperienced company in the manufacture of such a sensitive defence equipment?

(c) whether the services of trainee officers/soldiers, disabled during the training, are terminated and if so, number of such cases during the last three years; and

(d) details of the facilities provided to such officers/soldiers?

Committee for review of capital acquisition projects

*244. SHRI HARIVANSH: Will the Minister of DEFENCE be pleased to state:

(a) whether Government has any proposal to constitute a Committee to review the ongoing capital acquisition projects and suggest ways of taking them fruitful towards results; and

(b) if so, the details thereof?

Identification of eligible BPL families

(a) whether Government proposes to display information regarding the State-wise list of people living Below Poverty Line (BPL) on the Internet, so that only the genuinely poor persons can be identified and can avail the benefits of Government sponsored schemes and ineligible people illegally availing of the benefits meant for poor persons can be identified;

(b) if so, details thereof and action taken in this regard;

(c) if not, how does Government proposes to identify the ineligible people who are living above the poverty line and misusing the benefits of Government facilities meant for BPL people; and

(d) the reaction of Government thereto?

Fund utilisation for MGNREGA and PMAY

(a) whether it is a fact that the provisions made for administrative costs under certain schemes including Pradhan Mantri Awas Yojana (PMAY) are not being fully utilised;

(b) whether it is also a fact that the total admissible administrative expenditure for MGNREGA was ₹ 3411 crore, of which ₹ 520 crore remained unspent; and

(c) if so, the details thereof?

Pollution control in the country

(c) whether Government is planning to improve/change the systems for pollution control; and

(d) if so, the details thereof and if not, the reasons therefor?

(d) whether Government has assured the Apex Court that said vacancies will be filled up by March, 2018;

(e) if so, details thereof and steps taken by Government in this regard and if not, reasons therefor; and

(f) by when these vacancies would be filled?

Road safety in the country
