Disciplinary proceedings and investigations against IPS officers

*46. SHRI SANJIV KUMAR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) how many IPS officers are currently facing disciplinary proceedings and investigations by Central and State investigating agencies;
- (b) in reference to part (a) above, in how many cases FIRs have been registered and after investigation, chargesheets have been filed; and
- (c) how many IPS officers have been retired by Government by invoking Rule 16(3) of the AIS (DCRB) Rules, 1958 since 2014?

Unemployment among youth

*47. MS. DOLA SEN: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) how many unemployed youth have been given employment by the Central Government during the last one year; and

- (b) how many youth were employed during the last three years?

Revision of retail prices of petrol/diesel/LPG

*48. SHRI D. RAJA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) how many times the retail prices of petrol, diesel and LPG were revised, give the date and the amount increased/decreased, since May, 2014;

- (b) what is the tax component in these prices; and

- (c) what are the details of variation in crude prices during this period?

Investigations into killings of Kashmiri Pandits

*49. SHRI AMAR SINGH: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that a large number of FIRs registered for the killings of Kashmiri Pandits in the 1990s have not been investigated by the State Government of Jammu and Kashmir;

(b) whether it is also a fact that leaders of Kashmiri Pandit body had also approached the Central Government in this regard but no action was taken thereon; and

(c) if so, what are the specific reasons therefor and by when directions are proposed to be issued to the State Government of Jammu and Kashmir to initiate investigations into the killings of Kashmiri Pandits?

Fall in prices of pepper

*50. SHRI K. RAHMAN KHAN: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) whether it is a fact that prices of superior quality pepper have fallen due to increase in its production;

(b) whether it is also a fact that cheap and low quality Vietnamese pepper is finding its way into India through Sri Lanka under South Asian Free Trade Area Agreement which is severely impacting pepper growers in south Indian States, particularly Kerala and Karnataka; and

(c) what measures the Ministry propose to take to stop the unethical inflow of inferior quality pepper from Vietnam through Sri Lanka so that the prices of

pepper get stabilized and its growers are protected?

Increase in prices of petrol and diesel

(a) whether Government has decided to fix the prices of petrol and diesel on a daily basis and whether it is a fact that the prices of petrol and diesel have been rising continuously since this decision was taken even as the price of crude oil is very low in the international market;

(b) if so, the reasons therefor; and

(c) if not, the details of total cost of production of petrol and diesel and their delivery to the market?

Skill development in Saansad Adarsh Grams

(a) the number of employment opportunities created till date for the skilled manpower in Saansad Adarsh Grams, the State-wise details thereof;

(b) the details of various schemes implemented for the skill development and creation of employment in Saansad Adarsh Grams; and

(c) whether any assessment has been made about the economic growth of such villages, if so, the details thereof?

Increase in incidents of lynching by mob

- (a) whether incidents of lynching by mob are reportedly on the rise in the country and if so, the details thereof and the reasons therefor;
- (b) the total number of such cases reported, persons killed/injured, arrested and the action taken against them during each of the last three years, State-wise;
- (c) whether Government has any proposal to bring a stringent law against mob lynching and if so, the details thereof; and
- (d) the other measures taken by Government to stop such incidents in future?

Removal of prohibition on pulses' export

*54. SHRI D. KUPENDRA REDDY: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

- (a) whether Government has removed the prohibition on export of all types of pulses;
- (b) if so, the details thereof and the reasons therefor;
- (c) whether Government has taken steps to ensure availability of pulses at affordable prices in the country while according permission for pulses' exports; and
- (d) if so, the details thereof?

Encroachment of historical and archaeological sites

- (a) the details of historical and archaeological heritage sites marked by Archaeological Survey of India (ASI) in Gwalior;

- (d) if so, the details thereof?

Border Outposts along India-Bangladesh border

(d) if so, the details thereof and if not, the logic for fixing the National Minimum Wage?
