Human trafficking in Jharkhand

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that human trafficking is taking place on a large scale from the remote forest and tribal areas of Jharkhand namely, Khunti, Dumka, Simdega, Gumla, Ranchi, Chaibasa, Lohardaga and Palamu;

(b) whether it is also a fact that touts play an important role in well planned human trafficking;

(c) whether the Central and State Government have prepared a list of touts on the basis of intense surveillance; and

(d) if so, by when strict action would be taken and human trafficking would be stopped?
