#### **Loans written off by PSBs**

†\*106. SHRI MOTILAL VORA: Will the Minister of FINANCE be pleased to state:

(a) whether Government is aware that Public Sector Banks (PSBs) have written off ₹ 81,683 crore in the year 2016-17, whereas in the year 2012-13, this amount was just ₹ 27,231 crore;

(b) whether it is a fact that State Bank of India had written off loans of ₹ 20,339 crore in the year 2016-17;

(c) the total amount of loans written off by various nationalised banks in the year 2017-18; and

(d) the amount of loans given to farmers out of those written off amount?

#### **Financial restructuring of Air India**

\*107. SHRI RIPUN BORA: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether Government proposes to

reform Air India by means of any specific Alternative Mechanism before divesting;

(b) if so, the details thereof and if not, the reasons therefor;

(c) whether it is a fact that the previous Government had approved ₹ 30,000 crore turnaround and financial restructuring package spanning upto 2021 for Air India; and

(d) if so, the details of improvement in its financial operations management?

#### **Exorbitant medical fees charged by private hospitals**

\*108. SHRI AMAR SINGH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government is aware that private sector hospitals which cover 80 per cent of India's healthcare often indulge in systematic loot and extract huge money from the patients often running into lakhs;

(b) if so, how many such cases have been noticed during last six months;

(c) whether it is also a fact that private hospitals have to keep showing increasing profits every year to be considered a success and charge exorbitant charges from the patients; and

(d) if so, what is Government's reaction in this regard and by when this problem is likely to be addressed by Government?

#### **Evasion of GST by e-Commerce companies**

Will the Minister of FINANCE be pleased to state:

(a) whether Government is aware that certain e-Commerce companies in the country have violated the licensing policy and evaded Goods and Services Tax (GST);

(b) if so, the details thereof and the action taken by Government in this regard; and

(c) whether any mechanism has been developed and monitoring done to see that online trading by e-Commerce companies entirely come under the tax net and the revenue is recovered?

#### **Loss of market capital by PNB**

(c) the details thereof, State-wise?

#### **FDI in different sectors**

#### **Water scarcity at thermal power plants**

(a) whether it is a fact that India lost about 14 terawatt hours of thermal power generation due to water shortage in 2016;

(b) whether it is also a fact that this has led to the cancelling out of more than 20 per cent of growth in the country's total electricity generation from 2015;

(c) whether it is also a fact that about 40 per cent of the country's thermal power plants are facing great stress in terms of water availability; and

(d) if so, the details thereof?

#### **Projects sanctioned to Karnataka Biodiversity Board**

\*114. SHRI K. C. RAMAMURTHY: Will the Minister of AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY be pleased to state:

(a) whether it is a fact that some projects have been sanctioned to Karnataka Biodiversity Board in 2015-16 relating to medicinal plants protection and documentation;

(b) if so, the details of the projects and the present status of the same; and

(c) what are the other activities that are taken up under National AYUSH Mission in Karnataka?

#### **Divestment plan of Air India**

\*115. SHRI A. K. SELVARAJ: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether it is a fact that Government is considering to split Air India into four separate companies and offer at least 51 per cent in each of them as part of a divestment plan;

(b) if so, the details thereof;

(c) whether it is also a fact that the core airline business comprising Air India and Air India Express will be offered as one company and the process will be completed by the end of 2018; and

(d) if so, the details thereof?

#### **MMR and IMR of West Bengal**

\*116. SHRI MANAS RANJAN BHUNIA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the Maternal Mortality Rate (MMR) and Infant Mortality Rate (IMR) in the different States of the country; and

#### **Commercial air services from Tezpur, Assam**

(c) whether any proposal or clearance is pending with the Civil Aviation Ministry to start these air services; and

(d) what is Government's response to these proposals to have better and daily air connectivity to Kolkata and Delhi?

#### **Direct Benefit Transfer to TB patients**

(b) if so, whether such a proposal has been implemented, if not, the reasons therefor along with timeline by which this would take place;

(c) whether there is delay within Government on providing Direct Benefit Transfer to TB patients, if so, the reasons therefor; and

(d) whether Government has prepared a clear implementation plan and an evaluating system to effectively monitor the execution of the proposal?

projects furnished by Odisha Renewable Energy Development Agency under MNRE-UNDP-GEF assisted project in Scale up of Access to Clean Energy for Rural Productivity Uses?
