# Employment of women in defence forces

- (b) whether there has been an increase in the number of women joining the defence forces during the last three years and during the current year; and
- (c) details of the schemes being introduced by Government to incentivise women and increase their participation in the defence forces?

- (d) steps taken by Government to deal with this menance?
