**Farmers demands on new farm laws**

**46 Shri Bikash Ranjan:**

Will the Minister of **Agriculture and Farmers Welfare** be pleased to state:

- (a) the reasons for not accepting the charter of demands of the farmers; and
- (b) the reasons for not repealing the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020, the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020 and the Essential Commodities (Amendment) Act, 2020?

**Amending the Prevention of Cruelty to Animals Act, 1960**

Will the Minister of **Fisheries, Animal Husbandry and Dairying** be pleased to state:

- (a) whether Government is considering to amend the Prevention of Cruelty to Animals Act, 1960 and make it more stringent to prevent the infliction of unnecessary pain or suffering on animals, especially after an elephant was suspected to have consumed a pineapple filled with powerful firecrackers which exploded in its mouth in the Silent Valley forest; and
- (b) if so, the details thereof?

**Cold storages for fish**

- (c) if not, the reasons therefor?
