Fatalities and displacement of people due to Climate Change

136 Shri Narain Dass Gupta:

Will the Minister of **Environment, Forest and Climate Change** be pleased to state:

- (a) the number of fatalities and people displaced due to climate change triggered events in 2020, State-wise;
- (b) whether any compensation has been provided to the victims;
- (c) if so, the details thereof; and
- (d) if not, the reasons therefor?

Environmental Impact Assessment

137 Shri Bikash Ranjan:

Will the Minister of **Environment, Forest and Climate Change** be pleased to state:

- (a) the need to dilute the Environmental Impact Assessment (EIA) by Government when there is already a high rate of depletion of natural resources and environmental degradation has tremendous impact on human health and the details of the beneficiaries of this relaxation;
- (b) the reasons for reducing the notice period and rushing the EIA process;
- (c) the reasons for ex-post facto project clearance being contemplated; and
- (d) the details of the projects which were started after the ex-post facto project clearance?

Online single window clearance portal for coal mines

- (d) whether Government proposes to develop a green belt in the near future in all the Highways especially in Rajasthan, Madhya Pradesh, Haryana and Uttar Pradesh; and
- (e) the details of plan outlay and procedure for such proposals?

Budgetary allocation to the Ministry

- (d) if so, the details thereof and if not, the reasons therefor?

Commercial coal mining

(c) the details of private sector investments for commercial coal mines and whether the move will also have a significant role to play in making India a five trillion dollar economy by removing restrictions of the mining blocks, if so, details thereof?

Expenditure incurred on forest cover by Government

(c) the per hectare expenditure during the last three years on forest and wildlife area and the percentage of the annual State budget for this;

(d) whether allocated budget is sufficient to protect this vital national resource; and

(e) the steps being taken by Government to increase budgetary allocation to this sector?

Quantity of water provided in rural areas
