Development of tourist spots

- †*1. SHRI R. S. GAVAI: Will the Minister of TOURISM be pleased to state:
- (a) whether it is a fact that Government are considering to develop some new tourist spots;
- (b) if so, the details of the tourist spots likely to be developed; and
- (c) the steps being taken by Government to introduce the 'Incredible India' in the real sense of the term in the tourism market?

Unique Identification Number for transaction of equity/mutual funds

- *2. SHRI DHARAM PAL SABHARWAL: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that according to a circular issued by the Securities and Exchange Board of India (SEBI), it has become mandatory for investors to obtain Unique Identification Number (UIN) for transaction of equity/mutual funds;
- (b) if so, the details thereof, and the reasons therefor;

- (c) whether it is also a fact that the companies issuing such UIN are charging Rs. 300/- per registration which is exorbitant; and
- (d) if so, what steps Government propose to take to reduce the charges to Rs. 30/-, which is reasonable in view of administrative cost of issuing UIN?

Guidelines for air rights to private airlines
