# Effect of industrial discharge on ground water in Hyderabad

- \*181. SHRI YADLAPATI VEKAT RAO: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether Scientists of Acharya N.G. Ranga Agricultural University, Andhra Pradesh, have found in a study that indiscriminate disposal of effluents from industrial complexes in Hyderabad is affecting the quality of ground water; and
- (b) if so, whether Government propose to send a team to see the seriousness of situation and provide assistance in the setting up of treatment plants?

# Loss to Urea manufacturers by new pricing policy
