Privatisation of rail routes

†*581. PROF. R.B.S. VARMA: Will the Minister of RAILWAYS be pleased to state:

- (a) whether proposals have been invited from private sector for running trains on the rail routes going in losses;
- (b) if so, the details of the number of rail routes for which proposals have been received from private sector for running trains; and
- (c) the details of the terms and conditions of the agreements made with private sector by Government for running trains by them?

Uneconomic branch lines

*582. SHRIMATI AMBIKA SONI: DR. T. SUBBARAMI REDDY:

Will the Minister of RAILWAYS be pleased to state:

- (a) whether Railways have decided to weed out uneconomic branch lines and have issued instructions for closure/dismantling of 21 such lines;
- (b) whether high level Expert Committee had unanimously recommended

that where alternative modes of transport exist or can be developed, such branch lines should be closed down;

- (c) if so, the States in which these lines exist;
- (d) whether States have offered to provide help and assistance for not weeding out these uneconomic branch lines;
- (e) if so, the reaction of Government thereto; and
- (f) by what time the final decision in this regard is likely to be taken?

Allocation for agriculture and rural development in Gujarat

- *583. SHRI RAJU PARMAR: Will the Minister of AGRICULTURE be pleased to state:
- (a) the per capita amount allocated for agriculture and rural development during the last three years, especially for drought prone areas of Gujarat; and

- (d) details of machinery established for co-ordination with the academic fraternity to ensure that genuine research proposals are properly evaluated and are also not unduly delayed?

Vocational schools in Gujarat

Prevention of sugarcane pest

- (b) if so, whether an area of 1.32 lakh hectares of sugarcane crop in Maharashtra and 0.87 hectares in Karnataka were found infested by the aphid pest;
- (c) whether any Central team has visited these States in March, 2003;
- (d) if so, whether the team has submitted any report; and
- (e) if so, what preventive measures Government propose to take in this regard?

Interim order on life saving medicines

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether the Supreme Court has issued interim order asking the Government to lay down the criteria to bring essential and life saving medicines under price control by 2nd May, 2003;
- (b) if so, whether Government have considered the interim order of the Supreme Court;
- (c) whether Government are set to explore all options to push through the policy of progressive decontrol;
- (d) if so, whether the Health Ministry and Law Ministry have been consulted on this issue; and
- (e) if so, by what time the final decision in this regard is likely to be taken?
