- (b) whether the Ministry is considering to open a C.N.G. filling station in Dehradun, the capital of Uttaranchal; and
  - (c) if not, the reasons therefor?

### Status of tourism industry

- \*2. SHRI K. RAHMAN KHAN: Will the Minister of TOURISM AND CULTURE be pleased to state:
- (a) the present status of tourism industry of the country as compared to those of prominent countries; and
- (b) what is the expectation for the current year and the steps taken to reach the target of three million international tourists for the country?

## Profits of overseas branches of SBI and IOB

- (c) what steps have been taken to improve the situation?

### Pipeline for transportation of oil
