- (c) by when these teachers would be paid their arrears; and
- (d) the action proposed to be taken against the persons responsible for this criminal apathy and delay?

- (b) whether it is a fact that the school has sold xerox copies of forms, which is against the applicable rules;
- (c) whether it is also a fact that the school put up a Notice Board on 1st April, 2002 on its entrance, saying that there is no vacancy from II to IX classes; and
- (d) if so, the reasons for issuing a large number of application forms without offering a single seat from classes II to IX?

Conversion of agricultural land for non-agricultural purposes
