FTA with Thailand

- (a) the terms of Free Trade Agreement with Thailand:
- (b) whether it is also a fact that due to heavy reduction in the import duty on 82 items imported from Thailand, the goods of Thailand are cheaper than that of India;
- (c) if so, the steps being taken by Government to save Indian industry from closure; and
 - (d) if not, the reasons therefor?

Producing energy from garbage
